Appeal Hearing regarding 30 Wilderness Trails, Friendswood Texas, otherwise described as ABST 83 & 128 PAGE 2 & 3 E HOPPEL & A JACKSON SUR TR 3 38.443 ACRS.

At a special meeting on December 2, 2024, the District assessed civil penalties totaling \$3,419,225.00 for violations of the District's Drainage Criteria Manual for construction activities occurring at the site. The Respondent timely requested appellate review per Article V of the Drainage Criteria Manual. This hearing is written notice per Article V subsection E of a hearing under which the respondent may appear before the District at this time and place in person, through any attorney or by its officer, director or managing partner to present additional argument and evidence as to the allegation that provisions of the District Criteria Manual have been violated and to offer additional witnesses, documents, and other evidence on the subject.

Any video or photo media shall be submitted at least 48 hours before the hearing to the District's Administrative Manager, Kathy Grace if the respondent desires to project any visuals onto screens so any USB devices, connections, or otherwise can be verified by the District for security purposes.

At the close of this appellate hearing the Board of Directors shall deliberate and vote to affirm, reverse, or vacate and modify the District's prior ruling. The majority decision of the District's Board of Directors shall constitute the final ruling of the District on the subject. If penalties are affirmed or modified, the appellant shall have thirty (30) days to pay any fees, including any reasonable and necessary attorney's fees for which evidence has been presented and the Board has awarded.
